TERMS AND CONDITION:-

1. The interested bidder shall have to deposit an amount of Rs. 1000/- (Rupees One thousand only) for respective vehicle at the time of auction for taking part in it. The said amount shall be refunded back to unsuccessful bidder after the auction.
2. The interested party can inspect the vehicle on working days during the office hours after obtaining permission from the undersigned.
3. The bidder should offer bid for a minimum of Rs. 1000/- (Rupees One Thousand only) above the upset price of the vehicle.
4. An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
5. The bid shall be considered as final only after approval of Committee and its decision as regards to any dispute arising in the course of the auction shall be final and binding on all the persons participating in the auction.
6. The successful bidder has to pay deposit 25% of the offered bid on the spot and full amount therefore within 3 days from the day of auction, failing which the amount of 25% paid will be forfeited to the Govt.
7. The successful bidder shall have to lift the auctioned vehicle within three days from the date of finalization of the auction after which this office shall not be responsible for its safe custody.
8. Right to accept or reject any bid or all the bids without assigning any reason is reserved by the Committee.
9. The bidder must submit a copy of PAN Card, resident proof i.e. Ration Card, Voter ID, Aadhaar Card, etc. for taking part in the process of bidding.

10. The vehicle will be handed over to the successful bidder only on receipt the balance payment.
11. The successful bidder will also be responsible for getting registration certificate of the vehicle transferred in his/her name at his own cost expeditiously. This office will not be responsible for any laps of his part in this regard.
12. If due to some unforeseen reasons auction could not be take place on that day, the same will be conducted on the next working day at the discretion of the undersigned.
13. Dispute, if any shall be subject to Diu jurisdiction only.
