TERMS & CONDITION:

1. The auction of Toyota Qualis, bearing Registration No. DD-03-E-0019 shall be carried out under the supervision of the committee consisting of President, Vice President, Chief Executive Officer, Accountant, District Panchayat, Diu on 08/12/2016 at 03:30 P.M.
2. The interested bidder shall have to deposit a demand draft of ₹. 1000/- (Rupee One Thousand Only) in favour of Chief Executive Officer, District Panchayat, Diu for respective vehicle at the time of auction for taking part in it. The said draft shall be returned back to the unsuccessful bidder after the auction. The successful bidder has to deposit a demand draft in favour of Chief Executive Officer, District Panchayat, Diu of 10% of the offer bid on next day.
3. The bidder should offer bid for a minimum of ₹. 1000/- (Rupees One Thousand Only) above the upset of the vehicle.
4. An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
5. The upset of vehicle is ₹. 86,000/- (Eighty Six Thousand Only) for Toyota Qualis, bearing Registration No:- DD-03-E-0019.
6.
