Terms and conditions :-

- 1) This auction is on the condition "as is and where is" basis.
- 2) The starting bid amount will be "Upset Price" of the Items.
- 3) The auction shall be held on bid system. Interested bidder shall have to deposit a token amount of ₹ 1,000/- on 26-7-13 at 04:00 AM/PM for taking part in it. The said amount shall be refunded back to the unsuccessful bidder after the auction.
- 4) An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
- 5) The successful bidder shall have to deposit an amount equal to 50% of the highest bid offered as **Security Deposit** on the spot. Further he has to deposit **balance amount within three days** from the date of issue of letter accepting highest bid at his own cost. This department shall not be responsible for any loss/damage of the items if successful bidder fails to lift the items within stipulated time.
- 6) The successful bidder shall have to lift the auctioned vehicles within three days from the date of issue of letter accepting highest bid after which this office shall not be responsible for their safe custody.
- 7) The interested parties should inspect the items and satisfy themselves about their conditions etc. during office hours on any working day upto 25-07-2013
- 8) **No bidder will be allowed to register his name on the day of auction possibly.**
- 9) The bid shall be considered as final only after the approval of the competent authority and its decision as regards shall be final and binding on all the persons participating in the auction.
- 10) In case of failure of the highest bidder to deposit the amount of 50% of total amount of his/her bid, the deposit as made for security eligibility to participate in the auction will be forfeited to the government.
- 11) In case of failure by the highest bidder to lift the items within the given period, the amount of 50% of the total amount as per bid will stand forfeited to the Government.
- 12) The periodic rate of bidding amount shall not be less than ₹ 1000/- or rounded in thousands per bid. (for example in 1000, 2000, etc...)
