TERMS AND CONDITION:-

1. The interested party can inspect the vehicle on any working days during the office hours.
2. The interested bidder shall have to deposit an amount of Rs.1000/- at the time of auction for taking part in it. The said amount shall be refunded back to unsuccessful bidder after the auction.
3. The successful bidder has to pay deposit 25% of the offered bid on the spot and full amount therefore within 3 days from the day of auction, failing which the amount of 25% paid will be forfeited to the Govt.
4. The bidder will start with the upset price as shown in the auction notice.
5. The eligible participant will offer bid in the round-up of Rs.500/- for above upset price.
6. The vehicle will be handed over to the successful bidder only on receipt the balance payment.
7. The successful highest bidder will have to lift the vehicle upon the payment of full amount as per his bid within 10 days from the date of issue of letter accepting his / her highest bid amount from the date of finalizing of the auction by submitting documentary evidence in support of residential status (Ration Card / Voter Identity Card in the case of individual and Registration Certificate in case of firm etc.)
8. The successful bidder will also be responsible for getting registration certificate of the vehicle transferred in his / her name at his own cost expeditiously. This office will not be responsible for any laps of his part in this regard.
