C I R C U L A R

The Festival season of Diwali attract large number of tourist in Diu. In order to maintain Law & Order and to facilitate the tourists during diwali Festival season the following instructions are issued for the compliance of various departments/officers.

- 1) Vide Notification No.86-1-2002/03/MV/2016-17/198 dated 24/10/2016 the main Road from Jethibai Circle up to P.W.D. Office, Diu is declared as One Way for Light Motor Vehicle and No entry for Heavy vehicles, from 9:00 a.m. to 10:00 p.m. from 29/10/2016 to 06/11/2016. Similarly Parking Zones, No Parking Zones, drop & pick-up Zones for tourist Buses have also been declared. The SHO Police Station, Diu shall enforce this Notification by putting sufficient Police officials on duty at concerned Roads and parking zones. Special attention to be paid on road starting from Bunder Chowk to Fort and Road starting from Hotel Rasal to Parking place at Festa De Diu, where road is very narrow. The Police personnel put on duty at these roads may be directed to insure that vehicle should not be halted on road.
- 2) The Sub Divisional Police Officer/SHO, Diu shall give special attention to traffic regulation/control and Law and Order.
- 3) Proper security arrangements shall be made by SHO, Diu in the entire district and especially at the thickly congregated/vulnerable areas like Bunder Chowk, Nagoa, Main Bazar etc.
- 4) The Executive Magistrate shall patrol the respective area and assist the police in maintaining Law & Order and traffic regulation.
- 5) The SHO, Diu shall open an assistance cell for the benefit of the tourists.
- 6) The Deputy Director of Transport/MVI shall also regulate the traffic and shall book the cases against the offenders who violate Motor Transport Act and Rules and Notification dated 24/10/2016
- 7) The Fire Officer shall keep alert the staff to meet any emergency.
- 8) The Health Officer, CHC, Ghoghla will keep ambulance and the other medical service available round the clock to deal with any emergency at CHC, Ghoghla, Vanakbara and Govt. Hospital, Diu. The Health Officer shall also put a First Aid Cell at Nagoa Beach during whole Diwali season to meet any Medical Emergency alongwith Medical staff with banner for information tourists.



- 9) The Dy. Director of Tourism, Diu shall inform all Hoteliers of Diu to Co-operate with the Police Authorities on duty to maintain traffic Regulations and not to allowed parking of vehicles in front of Hotels as Parking on road is restricted vide Notification dated 24/10/2016 in Diu District from 29/10/2016 to 06/11/2016.
- 10) No Vehicles should be allowed to go to anywhere near beaches.
- 11) The Sub Divisional Magistrate, Diu shall co-ordinate the activities of Police, Executive Magistrate, Medical Service, MVI on day to day basis.
