



**NOTIFICATION**

No. 7-15/EC/DD/2017: Whereas, the proposals for the delimitation of thirteen wards of Diu Municipal Council (DMC) were published in the Official Gazette on 21<sup>st</sup> March, 2017, inviting suggestions / objections thereto by 31<sup>st</sup> March, 2017, in compliance with rule 3(2)(a) of the Daman and Diu Municipalities (Election) Rules, 1995;

And whereas, no suggestion or objection was received till the specified date and time by the Election Commission for the Union Territory of Daman and Diu. However, the Election Commission gave a personal hearing to all the stakeholders including the political parties and the sitting Councillors of Diu Municipal Council at the Conference Hall, Circuit House, Jalandhar Beach, Diu on 03.04.2017 at 4.00 P.M. All the political parties and the Councillors present were unanimous in their endorsement of the proposed boundaries of the thirteen wards of the Diu Municipal Council. A resolution passed by the Diu Municipal Council in its special meeting held on 23.03.2017 in this regard is also placed on record;

Now, therefore, in pursuance of section 10(1) and (2) of the Daman and Diu Municipalities (Amendment) Regulation, 1994, read with rule 3(2)(d) of the Daman and Diu Municipalities (Election) Rules, 1995, the Election Commission for the Union Territory of the Daman and Diu, appointed under section 185 of the Andaman and Nicobar Islands (Municipal) Regulation, 1994, and keeping in view the sentiments of the public of Diu Municipal area, the views of the UT Administration of Daman and Diu and other relevant factors such as the minimal increase in decadal population, voter population as per latest Parliamentary electoral roll etc., orders that the proposals for delimitation of the thirteen wards of Diu Municipal Council published vide this Commission's Notification No. 7-15/EC/DD/2017 dated 21.03.2017 shall be the final delimitation of the thirteen wards of Diu Municipal Council for the forthcoming General Elections.
