NOTIFICATION

In exercise of the powers conferred on the undersigned under Sub-Section (2) of Section 112 and Section 116 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) read with Government Notification No. HD-25-5389/65 dated 05th June, 1965, The undersigned hereby order the restriction of limits of speed of Motor Vehicles in the interest of public safety and convenience by fixing such maximum speed Limits for all class of Motor Vehicles on particular roads as mentioned at Column No.2 of the Schedule within Diu District and also authorize the erection of traffic sign boards mentioned in Column No. 3 of the Schedule under the powers conferred on the undersigned by Section 116 of the above said Act, for the purpose of regulating the traffic as aforesaid.
