NOTIFICATION

In exercise of the powers conferred on me under Section 217, 115, 116 & 117 of Motor Vehicle Act. 1988 and after consulting the Superintendent of Police & local Authority, **I, P. S. Jani**, District Magistrate & Collector, Diu. hereby Notify the following routs & Places as **One Way Roads, Restricted Zone for Entry of Vehicle, No Parking and Parking Zone**, as under:

- Restrict traffic on roads mentioned in Col. No. 2 of SCHEDULE-I
- Parking Zone at Places mentioned in Col. No. 2 of SCHEDULE-II
- No Parking at Places mentioned in Col. No. 2 of SCHEDULE-III
- Dropping & Pick-up point for Heavy Vehicle & Bus at Places mentioned in Col. No. 2 of SCHEDULE-IV as mentioned below: -
