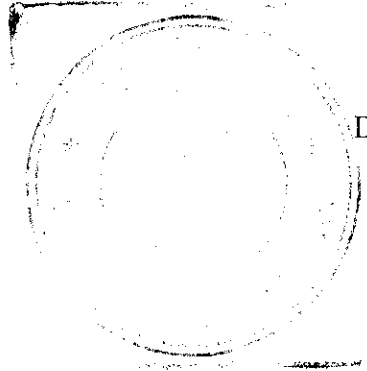
In view of the S.S.C. Examination-2013 which is scheduled to be held at:-
