ORDER

WHEREAS, the General Election to House of the People-2019, for 1-Daman & Diu Parliamentary Constituency is scheduled to be held on 23rd April, 2019 (Tuesday);

AND WHEREAS, I am satisfied that the adoption of immediate preventive measures are necessary for the maintenance of public peace and tranquility during the period ending with date of completion of election related process;

AND WHEREAS, I am satisfied that there are sufficient grounds for proceeding under Section 144 of the Code of Criminal Procedure, 1973 and that circumstances do not permit of serving notices individually in due time;

NOW THEREFORE, in exercise of the powers vested in me under Section 144 of the Code of Criminal Procedure, 1973, I, **HEMANT KUMAR, DISTRICT MAGISTRATE, DIU** hereby prohibit with immediate effect till 27th May, 2019 or till the process of general elections is over, whichever is later:

1. Carrying of firearms and ammunitions or sharp weapons of offences such as sticks or lathis, swords, daggers or spears, knives or any kind of other articles which is capable of being used for causing physical injury in public places.
2. Use of mobile loud speakers, fire crackers and taking out processions between 10:00 P. M. to 6:00 A. M.
3. Conduct of public meetings and use of static loudspeakers between 10:00 P.M. to 6:00 A.M.
4. Use of mobile loudspeakers between 6:00 A.M. to 10:00 P. M. and static loudspeakers between 6:00 A.M. to 10:00 P.M. and conduct of public meetings without prior permission of the District Magistrate.

AND FURTHER direct that the above restrictions shall not apply to public servants on duty or where prior permission in writing has been obtained from the District Magistrate.
