ORDER

(Under Section 144 of Criminal Procedure Code, 1973)

WHEREAS, the World Health Organization has declared COVID-19 as a pandemic and the number of positive cases as a whole in the Country as well as in the neighbouring States are increasing, the Central Government had announced a 21 days of Total Lockdown from 25th March, 2020, and later extended for more 3 weeks up to 3rd may 2020 in public interest so as to contain spread of the said virus;

AND WHEREAS, this office has issued vide order No. 32-21-2009/MAG/2019-20/2134 dated 31/03/2020;


AND WHEREAS, since, the spread of the said virus is increasing at proliferating rate, the lockdown has been extended upto two weeks from 4th May, 2020 i.e. upto 17th May, 2020 to contain its spread in other areas;

AND WHEREAS, it is expedient to extend Lockdown as a precautionary measures and GOI guidelines;

THEREFORE, in view of above and the powers conferred under section 144 of Code of Criminal Procedure, 1973, **I, Saloni Rai, IAS, District Magistrate, Diu**, hereby order that the above mentioned orders shall remain in force till 17th May, 2020 till 11:59 p.m.

This Order shall come into force immediately from the date of issue and shall remain in force until 17th May, 2020 till 11:59 p.m.

As the Order cannot be served individually, the Order is put in the public domain for information and necessary action.
