CURFEW ORDER
(Under Section 144 of Criminal Procedure Code, 1973)

WHEREAS, Corona Virus (COVID-19) has been declared as pandemic by World Health Organization, urgent public Health measures are required to be taken to control the transmission of the Corona Virus;

AND WHEREAS, it is imperative that strict and intensified measures need to be undertaken with immediate effect in order to prevent and further contain the spread of the COVID-19 virus in the District of Diu;

AND WHEREAS, it is pertinent that social distancing and isolation measures for the containment of the spread of COVID-19 should be strictly adopted;

AND WHEREAS, UT Administration has extended the lockdown in containment zone, if so declare upto 31-08-2020 and to re-open more activities in a calibrated manner in areas outside the Containment Zones in the entire territorial jurisdiction of the U.T and issued guidelines for the same as referred above;

AND THEREFORE, in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, **I, SALONI RAI, IAS, District Magistrate, Diu** in the interest of Public Health Safety hereby order that **the movement of individuals, for all non-essential activities, shall remain strictly prohibited between 10:00 p.m. to 5:00 a.m except for essential activities.**

This order shall however, not apply to:-

- (1) Police personnel, (2) Military and Para Military Personnel in Uniform
- (3) Doctors, officers on emergency services & Govt. functionaries on duty on production of Identity Cards (4) Members of Home Guards on duty the persons to whom a permit is issued by the District Magistrate, Diu or any other officer authorized by me in this behalf.

This order shall come into force immediately from the date of issue and shall remain in force till 31st August, 2020.

As the notice cannot be served individually on all concerned, the order is hereby passed ex-parte. Any person contravening this order shall be punishable under section 188 of the Indian Penal Code.
