quarantined for 14 days and in case of default punishable action shall be initiated against them including filing FIR.

If found suspected, the same has to be reported to the Health Officer, Community Health Centre, Ghoghla, Diu and further action initiated as per the SOP issued by MoHFW. A daily report of all the persons screened shall be sent to Secretary (Health) D&NH and DD, Daman & Collector, Diu for kind information.

The visiting teams shall follow the hygiene protocols including washing of hands, wearing masks etc at all times during their visit.
