ORDER

(Under Section 144 of Criminal Procedure Code, 1973)

WHEREAS, the World Health Organisation has declared COVID-19 as a pandemic and the number of positive cases as a whole in the Country as well as in the neighbouring States are increasing;

AND WHEREAS, as per World Health Organisation, one of the most effective strategies to fight the COVID-19 epidemic is isolation of suspected cases;

AND WHEREAS, in such a scenario, quarantining any person with flu-like symptoms shall help in breaking the chain of transmission of all flu viruses, including COVID-19 virus;

THEREFORE, in view of the above and the powers conferred under section 144 of Code of Criminal Procedure, 1973, **I, SALONI RAI, IAS, District Magistrate, Diu** hereby order that any person with Flu like symptoms shall report to the nearest health care facility such as Govt. Hospital, Community Health Centre and Primary Health Centre.

All Medical Officers of Govt. Hospital, Community Health Centre and Primary Health Centre shall be responsible for intimating any such case to Health Officer, Community Health Centre, Ghoghla, Diu.

Any such person who is not required to be tested for COVID-19 or quarantined as per the Ministry of Health and Family Welfare Guidelines, shall as an abundant measure of caution be immediately home quarantined.

A list of all such persons shall be submitted to the Superintendent of Police daily by Health Officer, Community Health Centre, Ghoghla, Diu who shall ensure that these persons remain in home quarantine for at least a week after the symptoms subside.

This Order shall come into force immediately from the date of issue and shall remain in force for 60 days from issue of this more.

As the Order cannot be served individually, the Order is put in the public domain for information and necessary action.
