ORDER

In the wake of Corona Virus (COVID-19), it is imperative to take precautionary steps towards the containment of the said virus;

AND WHEREAS, many tourists from various parts of the country are coming to visit Diu and it has been observed that tourists are not wearing mask and are roaming in Diu District without mask which may lead to the spread COVID-19 virus;

AND WHEREAS, this office had already issued order regarding penalties vide No. COL/DIU/DIS/DM-2005/2019-20/2519 dated 21/11/2020;

THEREFORE, in view of the above and in exercise of the powers conferred under Section 34 of Disaster Management Act, 2005, I, **Saloni Rai, IAS, District Magistrate, Diu** hereby order that the following penalties shall be levied and collected from all persons and entities violating the directions issued by the District Administration.
