**ORDER**

1. **WHEREAS**, the Respondent vide his letter dated 02/01/2017 had undertaken to remove the debris/ building material dumped at the Bus Station, Bucharwada, Diu i.e. on Government Land;

2. **AND WHEREAS**, the current court proceeding was initiated on the basis of the respondent's own written undertaking to remove the debris from the government Bus Station, Bucharwada, Diu dated 02/01/2017 which showed that the respondent had encroached on government land i.e. Bucharwada Bus Station, Diu;

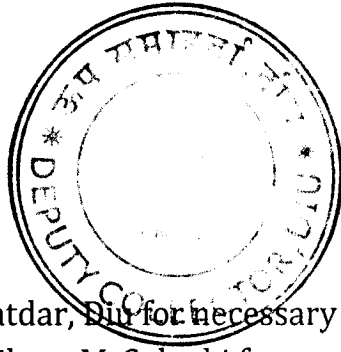
3. **AND WHEREAS**, in the respondent's undertaking dated 02/01/2017, he had requested for 07-10 days to remove the debris/ building material from the said government land;

4. **AND WHEREAS**, the respondent was personally present in the court on 23/01/2017 and submitted an application for adjournment on the grounds that "I got oral message from Rajesh Bariya, Surveyor that you have initiated action against me, for alleged violation but I have not received any official notice nor any written intimation has been given to me. Further you have not supplied me copy of the complaint and/or report of The Mamlatdar, Diu; which may please be given to me at the earliest, to defend the matter. For any legal action, I must be given written notice and I shall be given sufficient time for to defend my case. Further the process of removing the building materials from the site has been commenced and it will be removed within week from today";

5. **AND WHEREAS**, vide respondent's own submission on 23/01/2017, he has stated that the building material shall be removed within a week, which confirms that the debris/building materials have not been removed till date;

6. **NOW THEREFORE**, keeping the above facts, submissions and reasons in view, I, **Dr. Apurva Sharma, DANICS, Deputy Collector, Diu** in exercise of the powers conferred to me **under section 40** of **Goa, Daman and Diu, Land Revenue Code, 1968** do hereby **order the immediate removal of debris/Construction material of the respondent from government land bearing PTS No.41/0 (Part), situated at Bucharwada Bus Station, Diu** and also order that the **cost of removal of the debris from the said government land shall be recovered from the respondent in the form of arrears of land revenue, and direct the Mamlatdar, Diu to do the needful immediately.**
