ORDER

(Under Section 144 of Criminal Procedure Code, 1973)

WHEREAS, Corona Virus (COVID-19) has been declared as pandemic by World Health Organization, urgent public Health measures are required to be taken to control the transmission of the Corona Virus;

AND WHEREAS, it is imperative that strict and intensified measures need to be undertaken with immediate effect in order to prevent and further contain the spread of the COVID-19 virus in the District of Diu;

AND WHEREAS, it is pertinent that social distancing and isolation measures for the containment of the spread of COVID-19 should be strictly adopted;

AND WHEREAS, this office has issued various orders to effectively carry out the said Lock down as follows;

2. **No. 32-21-2009/MAG/2019-20/379 dated 12/05/2020.**

AND THEREFORE, in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, **I, SALONI RAI, IAS, District Magistrate, Diu** hereby order the extension of the lockdown as mentioned in above referenced order until 31st May 2020 till 11:59, or until directed otherwise.

As the notice cannot be served individually on all concerned, the order is hereby passed ex-parte. Any person contravening this order shall be punishable under section 188 of the Indian Penal Code.
