**READ: Order No. DMHS/COVID-19/2020/4209 dated 18/05/2020 issued by Secretary(Health & Family Welfare), Dadra & Nagar Haveli and Daman & Diu, Secretariat, Daman.**

## **ORDER**

**WHEREAS**, in the wake of Coronavirus (COVID-19), which is declared as pandemic by the World Health Organization (WHO), the Central Government had ordered a total lockdown throughout the country for 21 days from 25<sup>th</sup> March, 2020. Under further directions of Ministry of Home Affairs, the lockdown period was extended from time to time upto 17/05/2020;

**AND WHEREAS**, due to increased number of cases of COVID-19, the Central Government has further extended the said lockdown till 31<sup>st</sup> May, 2020, so as to contain the spread and local transmission of the said virus;

**AND WHEREAS**, it is imperative to take precautionary steps towards the containment of the said virus;

**THEREFORE**, in view of above and in exercise of the powers conferred in Section 34 of Disaster Management Act, 2005, **I, Saloni Rai, IAS, District Magistrate, Diu**, hereby order that the following penalties shall be levied and collected from all persons and entities violating the directions issued by the District Administration.

3	Spitting including spitting of Tobacco, Gutka, etc. in public places	Rs. 100/-	Rs. 200/-	

The above direction including imposition of penalties shall be enforced by Police Department, Diu Municipal Council, District Panchayat, Gram Panchayat and Incident Commander & Special Executive Magistrates.



The order shall come into force with immediate effect and shall remain in force till further orders.
