**READ: Order No. DMHS/COVID-19/2020/4209 dated 18/05/2020 issued by Secretary(Health & Family Welfare), Dadra & Nagar Haveli and Daman & Diu, Secretariat, Daman.**

**ORDER**

**(Under Section 144 of Criminal Procedure Code, 1973)**

**WHEREAS**, Corona Virus (COVID-19) has been declared as pandemic by World Health Organization, urgent public Health measures are required to be taken to control the transmission of the Corona Virus;

**AND WHEREAS**, the lockdown period has been extended upto 31-05-2020 in the entire Diu District and as per the directives, a new guidelines on lockdown measures has to be implemented strictly;

**AND WHEREAS**, it is imperative that strict and intensified measures need to be undertaken with immediate effect and keeping in view the rising numbers of cases in adjoining Taluka of Una in Gir Somnath District, there is a need to restrict the movement of persons across check post of Diu District regard to essential and non-essential commodities, in order to prevent and further contain the spread of the COVID-19 virus in the District of Diu;

**AND THEREFORE**, in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, **I, SALONI RAI, IAS, District Magistrate, Diu** in the interest of Public Health Safety and higher restrictions in terms of movement hereby order as under;

1. Enhanced restrictions will be imposed in terms of movement of people across check-post. No entry will be allowed without valid permission issued from Collectorate, Diu.
2. **Vegetable Market in Urban area and Rural area will be open on 3 days a week i.e. Monday, Wednesday and Saturday on regular timings of 8.00 a.m. to 5.00 p.m.**
3. **Fish Market in Urban area and Rural area will be open all days on regular timings of 8.00 a.m. to 5.00 p.m.**
4. Other shops selling essential and non essential shops employing local residents of Diu may **open on all days in a week during on regular timings of 8.00 a.m. to 5.00 p.m.** ensuring social distancing and other hygienic practices at the shop.

5. Vendors of milk will be allowed movement on a daily basis after issuance of permit from check post.

This order shall come into force with immediate effect and shall remain in force till 31st May, 2020 upto 11:59 pm.

As the notice cannot be served individually on all concerned, the order is hereby passed ex-parte. Any person contravening this order shall be punishable under section 188 of the Indian Penal Code.
