ORDER

(Under Section 144 of Criminal Procedure Code, 1973)

WHEREAS, in the wake of the outbreak of Corona Virus(COVID-19) World Health Organization declared it as pandemic, urgent public Health measures are required to be taken to control the transmission of the Corona Virus;

AND WHEREAS, it has been observed that the spread of virus can be substantially reduced by wearing mask by persons coming in contact with others in addition to social distancing;


AND WHEREAS, it has become imperative in the larger public interest that wearing of mask by any person who is moving in any public place is essential;

AND THEREFORE, in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, **I, SALONI RAI, IAS, District Magistrate, Diu** hereby directs the following:-

1. All persons moving for whatsoever purpose and under whatever reasons in public places, like streets, hospitals, offices, work places, markets must wear Masks(3 ply or cloth mask) compulsorily.
2. Any persons moving around in his/her personal or official vehicle must be wearing these masks compulsorily.
3. All Persons/officials shall attend any meeting by donning masks.
4. The said masks above may be standard masks available with the chemists or even homemade washable masks which can be reused after proper washing and disinfection.
5. It shall be responsibility of the employer to ensure that his/her employees wear 3 ply masks or cloth masks without fail.

This order shall come into force immediately from the date of issue and shall remain in force till 3rd May,2020.

As the notice cannot be served individually on all concerned, the order is hereby passed ex-parte. Any person contravening this order shall be punishable under section 188 of the Indian Penal Code.
