ORDER

Sub:- Constitution of Social Impact Assessment Team under RFCTLARR, 2013.

In exercise of powers conferred by Rule 6 of the Right to Fair Compensation & Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2014, the Social Impact Assessment Unit hereby constitutes **Social Impact Assessment Team** for Acquisition of land bearing (1) Survey No. PTS-117/4, admn. 180 out of 5283 sq.mtrs., (2) Survey No. PTS-117/2, admn. 260 out of 12764 sq.mtrs., and (3) Survey No. PTS-116/39, admn. 454 out of 5747 sq.mtrs., situated at near Diu Fort behind Circuit House, Diu and south side of GHSS, Diu & Govt. 1. The SIA Team shall conduct the process of SIA as per Right to Fair Compensation & Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2014.

2. SIA team shall, based on the data collected, and in consultation with the affected communities and key stakeholders, prepares SIA Report in form II alongwith nature, extent and intensity of the positive and negative social impacts of proposed project and Land Acquisition alongwith terms of R&R and compensation.
3. The SIA team with support of Local Administration shall conduct public hearing of Draft SIA Report prepared under Rule -7. The draft SIA report shall be made available to Gram Panchayat and Municipality in local language. Public meeting shall be conducted in Gram Sabha/Diu Municipal Council in which Public Representatives, Local Volunteer organization, media shall be called with Representatives of Requiring body and Land Acquisition functionaries. SIA team to conduct public hearing as per rule 8.
4. Final SIA Report with Social Impact Management Plan in Form II is to be submitted by SIA team in local language and copy of such report & plan be made available to Panchayat, Municipality, Collector, SDM, Mamlatdar and shall be published in the affected area and put on website of the Government.
