

- 2) The amount will be paid on receipt of the articles as soon as bill is passed.
- 3) The items will be supplied within 15 days from the date of receipt of supply order at Diu College.
- 4) The dealer should be dealing in tendered items.
- 5) Late/Vague/conditional/incomplete/not conforming to the laid down procedure, bids in any respect will be rejected.
- 6) Tender document should be submitted along with non-refundable Tender fee of Rs. 100/- (Rs. One Hundred Only in form of Demand Draft (DD), and refundable E.M.D. of Rs. 4150/- (Rs. Four Thousand One Hundred Fifty Only) in form of Fixed Deposit Receipt (FDR) in favour of "**The Collector & Chairman and Principal & Member Secretary, DHES, Diu**" and should be valid for 6 months, the EMD of the successful bidders will be released only after satisfactory report of Asst. Professor (Phy. Edu.).
- 7) The tenderers shall fill in the tenders properly and carefully & rate should be quoted for the particular specification & brand only if rate actual for offer substitute tender will not be accepted.
- 8) The vendors shall not quote absurd rates or make corrections/over writings in the quotation.
- 9) The amount/rates quoted by the vendors must be legible and clearly indicated. And rate quoted in quotation from only.
- 10) Any tenders found containing any corrections/over writings shall be liable to be rejected as such.
- 11) Tender will be evaluated on the basis of the item wise L1.
- 12) The items which are **not found satisfactory and in accordance to the Specification & Brand same will be returned and to be replaced at the supplier's own cost. Failing to do supply order will be cancelled and order shall be passed on to next lower quoted Agencies and in future said agencies will not be eligible for any supply to this department.**
