Sealed tenders are invited on behalf of the Agriculture Section, District Panchayat, Diu from the registered manufacturer/distributors/agencies/suppliers for supply following **Organic Fertilizer & Bio-Pesticides** as detailed below on following terms and conditions upto **01/03/2018**.

TERMS AND CONDITIONS :

1. The interested parties should quote their rates on letter head under their signature & seal in tender form.
2. The rates should be inclusive of all Sales Taxes, packing/forwarding charges etc.
3. The rates should be valid up to 90 days.
4. The amount/rates quoted by the agency must be legible and clearly indicated.
5. The interested parties should have the above mentioned items ready in their stock for supply. The delivery of F.O.R is to be made at Agriculture Section, District Panchayat, Diu within 10 days from the date of issue of supply order.
6. The items to be supplied should have been produced/ manufactured/ packed/labeled and being sold in conformity with the provisions of relevant Acts/Rules in force.
7. To examine the credentials, the random sampling of the items will be done in accordance with established norms. The items found defective or damaged or otherwise not conforming to the given specifications will be rejected and the same will be liable to be replaced the same within specified period of time of 07 days.
8. The quantity to be supplied will be subject to replacement without prior notice.
9. The dealer should be registered with VAT Department of the State / UT in which its HO/Sale office is located and should submit the copy of GST Registration Certificate.
10. Bill should be submitted in duplicate, original one should be duly affixed with Revenue Stamp.
11. No advance payment will be made / paid until materials is received and will be paid on passing of bill. The payment will be made only direct bank account only after successful completion of supply to the satisfaction of the Chief Executive Officer, District Panchayat, Diu.
12. The sealed tender should reach this office on or **before 01/03/2018** upto 5:00 pm in the sealed envelop superscribed as "**Tender for supply of Organic Fertilizer & Bio-Pesticides.**" The tender will be opened on the same day by the purchase committee in presence of the parties or their authorized representative, if possible.
13. The terms and conditions of the notice including those prescribed by the office shall be acceptable to the supplier. No separate agreement will be executed for the purpose.
