LIMITED TENDER NOTICE

The Head of Office, Electricity Department, Diu hereby invites sealed Limited Tender on behalf of the President of India from firms for supply fixing and testing of CCTV camera at Solar power station Fudam and newly constructed 66 KV Sub Station Malala of Electricity Department, Diu. The specifications of the said work is mentioned in the separate form with following terms and conditions.

Copy of tender form can be availed from the Electricity Department, Diu during office working hrs. up to 16/11/2015 (3:00 P.M.) on payment of Rs. 500/- (Non-Refundable).

TERMS AND CONDITIONS:-

1. The Limited Tenders shall be submitted in a sealed envelope subscribed as Limited Tender for "supply fixing and testing of CCTV camera at Solar power station Fudam and newly constructed 66 KV Sub Station Malala of Electricity Department, Diu".
2. The rate should be quoted inclusive of all taxes.
3. The rate quoted should be only for standard company/make.
4. The every tender shall submit the Earnest Money of Rs. 10,000/- in the form of FDR/DD/Cheque along with Limited Tender form. The tenders received without EMD shall be rejected. The FDR/DD/Cheque of the scheduled Bank shall have valid period of 180 days from the date of receipt of the tender.
5. The rate quoted will remain valid and operative for a period of 180 days from the date of opening the tender.
6. The rate shall be quoted in the Proforma given in Part A of the tender form. The tenderer should sign & affix his seal at every places desire in Tender form.
7. The items and materials shall have to be delivered to the office of the Assistant Engineer Electrical, Electricity Department, Diu and will be inspected on site itself. The item/material used for installation of CCTV camera should be of standard quality confirming to the specification, otherwise shall have to replace the same and collect back the rejected materials at his own cost and risk in the event of any dispute, the decision of the undersigned shall be final and binding upon the supplier(s).
8. The Tender i.e. the tender form completed in all respect should reach in to this office on or before 18/11/2015 at 12:00 P.M. which will be opened on same day at 12:30 P.M. if possible in presence of available tenderer.
9. In any tender any correction, over writing will found will be treated as rejected.
10. Any tenderer quotes their rates should be clear and standard.
11. Any tenderer should not do any mistake, correction and not quote unnecessary rates.
12. The tenderer should be registered with VAT department.
13. The successful tenderer shall have to carry out and complete the said work within a period of 15 days or earlier from the date of receipt of the work order.
14. No advance payment shall be made to the success tenderer.
15. The tender can be view and available on the Government website www.diu.gov.in.
16. The Right to accept or reject all or any part of Limited Tender without assigning any reasons thereof is reserved by the undersigned.
17. A bill should be submitted in duplicate and should invariably mentioned the Number and date of work order with affixing proper revenue stamp.
