**Terms and Conditions for the “Refilling Medical Oxygen Cylinder Jumbo
“D” Type ” for Govt. Hospital, Diu.**

- 1) The rate(s) quoted should be strictly for free door delivery at FOR DIU and will be valid and operative for supply orders issued within One Year from the date of invitation of tenders.
- 2) The Rate should be quoted in the prescribed form given by the department; the Rate should be valid upto One Year from the date of tenderization.
- 3) All/Taxes/Duties/Royalties Charges payable on the sales/transport etc. within and/or outside the state shall be bear by the supplier.
- 4) Orders once placed should be delivered within the given time period and item should be door delivered.
- 5) No extra charge for packing, forwarding and insurance etc. will be paid on the rates quoted.
- 6) Rates quoted for items other than the required specification/make/manufacture will not be considered.
- 7) The decision of the Tender Inviting Officer for acceptance/rejection.
- 8) The Tenderer should enclose along with tender an amount of **₹. 500/-** as Demand Draft form payable at DIU in favor of **Head of Office, GOVT. HOSPITAL, DIU.** Tender received without DD will be summarily rejected.
- 9) The Tenderer should enclose along with tender an amount of **₹. 15,000/-** as Earnest Money Deposit in form of Fix Deposit Receipt from any of the Commercial Banks in an acceptable form payable at DIU in favor of **Head of Office, GOVT. HOSPITAL, DIU.** The EMD should not be forward by Cash. Tender received without Earnest Money Deposit will be summarily rejected.
- 10) (a) The successful tenderer will have to pay within 10 days from the date of demand, an amount equal to 10% of the total value of articles that may be ordered, as the amount of security deposit.
(b) Non receipt of Security Deposit within stipulated time will result in automatic cancellation of the order for supply without any intimation.
(c) However in case if any articles are received for which the Security Deposit may not have been deposited, the full Security Deposit as may be due from the supplier will be recovered from the bill(s) for such articles.

- 11) The amount of Earnest Money paid by the successful Tenderer(s) will be adjusted against the amount of Security Deposit to be paid by the successful tenderer(s) as per condition No.9 above.
- 12) **Supplier should bring & reach of Refilling Medical Oxygen Cylinder Jumbo “D” Type at Govt. Hospital, Diu.**
- 13) **The tender should be neatly typed or handwritten only on Letter Head carries the name of the supplier and the signature of the tenderer. No overwriting, correction or erasures will be considered.**
- 14) Only on satisfactory completion of the Services order for and on payment of all bills of the supplier, as to be admitted for payment, the amount of Security Deposit /Earnest Money will be refunded after expiry of guarantee/warranty period, if any, or any such date/period as may be mutually agreed upon.
- 15) The tender inviting officer will consider extension of time for remitting the Security Deposit as demanded. - 17) All bills for amount above ₹ 5000/- should be pre-receipted on a Revenue Stamp of proper value. Bills for amount exceeding Rs. 5000/- not pre-receipted on Revenue Stamp of proper value will not be accepted for payment.
- 18) The Tenders shall be submitted in separate envelope. - 19) The Tenders will be opened by the Tender Opening Committee in presence of Tenderers or their representatives, if any present in the Office of the Tender Inviting Officer.
