

(i) Three similar completed works costing not less than the amount equal to 40% of the Estimated Project Cost. Or Two similar completed works, costing not less than the amount equal to 60% of the Estimated Project Cost. Or One similar completed work of aggregate cost not less than the amount equal to 80% of the Estimated Project Cost. And (ii) One Completed work of any nature (either part of (i) above or a separate one) costing not less than the amount equal to 40% of the Estimated Project Cost with some Central Government Department/State Government Department/Central Autonomous Body/Central Public Sector undertaking/ State Autonomous Body/ State Public Sector undertaking / City Development Authority / Municipal Corporation of city formed under any act by central / state Government and published in Central / State Gazette.
