

Or One similar completed work of aggregate cost not less than the amount equal to 80% of the Estimated Project Cost. And</p> <p>Note:- For other than Govt. work the TDS certificate of deduction made by the Clint shall be submitted compulsory.</p> <p>The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of application for tender.</p>
