And (ii) One Completed work of any nature (either part of (i) above or a separate one) costing not less than the amount equal to 40% of the Estimated Project Cost with some Central Government Department/State Government Department/Central Autonomous Body/Central Public Sector undertaking/ State Autonomous Body/ State Public Sector undertaking / City Development Authority / Municipal Corporation of city formed under any act by central / state Government and published in Central / State Gazette.	
The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of application for tender.


