It is mandatory to submit tender fees and EMD online failing which the price bid of that agency will not be opened online and Physical submission of such scanned documents shall reach to office of the Executive Engineer within 3 (three) working days after closing of online bidding.
- Three similar completed works costing not less than the amount equal to 40% of the Estimated Project Cost.
Or
Two similar completed works, costing not less than the amount equal to 60% of the Estimated Project Cost.
Or
One similar completed work of aggregate cost not less than the amount equal to 80% of the Estimated Project Cost.
And
 - One Completed work of any nature (either part of (i) above or a separate one) costing not less than the amount equal to 40% of the Estimated Project Cost with some Central Government Department/State Government Department/Central Autonomous Body/Central Public Sector undertaking/ State Autonomous Body/ State Public Sector undertaking / City Development Authority / Municipal Corporation of city formed under any act by central / state Government and published in Central / State Gazette.
The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of application for tender.
