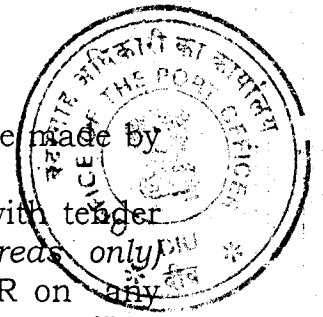

Sealed Tenders are invited on behalf of President of India by the Mamlatdar & H.O. of Port Office, Diu from the reputed Firm or Authorized Contractors/Agencies/ Manufacturers for Supply and fixing one number indigenous make of HTC , Kirloskar, Tata, Field Marshal or any standard company of suitable water cooled marine diesel Engine for Port Office, Diu, as detail mentioned below :-

Flywheel fitted with driving ring. The engine shall have 12V battery starting system and also emergency manual raised hand starting system. The engine should fix on existing foundation of hull and required nuts, bolts, washers, packing plates, etc., leveling with existing propeller shaft and gear box and Hull of the Motor Launch with all its mechanism (water pump with belt system) and complete starting in sea ride operation. 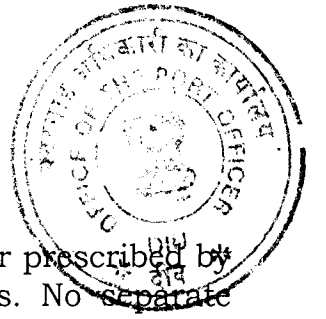
TERMS AND CONDITIONS :-

1. The rate(s) quoted should be strictly for free delivery and installation and fixing at F.O.R. Diu and will be valid and operative for one year from the date of issue of supply order.
2. All Taxes/Duties/Royalties Charges payable on the sales/transport etc. within and/ or outside the State shall be payable by the supplier. The rate should be quoted inclusive of all taxes, installation and commissioning charges etc..
3. Vat/ Sales Tax will be paid on the items on which it is chargeable under the Vat/ Sales Tax Act or Rules made there under
4. Except C.S.T. all other Taxes/ Duties/ Royalties charges payable on the Sales/ Transport etc. within and/ or outside the state of the supplier shall be payable by the supplier only.
5. No extra charges of packing, forwarding, installation of equipment, insurance etc. will be on the rates quoted.
6. The rates should be quoted only for the items specified in the list of requirements. Necessary specification marks, manufacture, drawing etc. for the items may be enclosed with tender form.



7. Overwriting should be avoided. Correction, if any, should be made by neatly crossing out, initialing, dating and rewriting.
8. The Tenderers/ contractors should submit E.M.D. along with tender an amount of Rs. 2,500/- (*Rupees Two Thousand Five Hundred only*) as Earnest Money Deposit by drawing a Demand Draft/ FDR on any Scheduled Bank at Diu in favour of the Mamlatdar and H.O, Port Office, Diu, received without Earnest Money Deposit will be summarily rejected. Any kind of exemption from producing EMD will not be considered even though SSI Units. EMD will be returned back to the unsuccessful bidder.
9. The Tender should be in sealed cover superscribed as “ **Tender for supply of water cooled Diesel Marine Engine** ” and should reach at the Office of the Port Officer, Diu on or before **30-01-2017 at 3-00 P.M.** and same will be opened at **4-00 P.M.** on the same day, if possible, in the presence of available Tenderers.
10. **SOPÈ OF WORK** :- The scope of work of the tenderer is to Supply and fixing one number indigenous make of HTC , Kirloskar, Tata, Field Marshal or any standard company of suitable water cooled marine diesel Engine of 24 to 34 HP @ 1800 RPM without gear box. as per detail mentioned in description above with defect liability period of one year from the date of installation . The Tenderers will also be responsible for repairs etc. within the liability period, no extra charges/ payment will be made or considered for such replacement of part/ parts in repairing works undertaken in this regard. The defect, if any noticed during the period shall immediately be rectified failing which the firm shall be liable for action. The tenderer has to supply the required essential spares free of cost for trouble free operation of the engine during defect liable period.
11. The Tenderer shall submit, tin/tan/vat/st/registration, etc., if any alongwith the Tender Form.
12. The department shall not be liable to pay any interest on the money deposited by the applicant.
13. It is duty of the tenderer to ascertain that the system supplied by them has to fit to the existing area/ foundation in engine room as shown and function effectively and efficiently as per the specifications etc.
- 14.(a) The successful Tenderers will have to pay within ten days from the date of demand, an amount equal to 15% of the total value of articles that may be ordered as the amount of Security Deposit, Otherwise EMD will be forfeited in Govt.
(b) Non receipt of Security Deposit within stipulated time limit will result in automatic cancellation of the order for supply without any intimation.
15. The amount of Earnest Money Deposit paid by the successful tenderer(s) will be adjusted against the amount of Security Deposit to be paid by the successful tenderer(s) as per condition No.14 above, if required.
16. The decision of the Tender Inviting Officer for acceptance/ rejection of any articles supplied including of equivalent specification, standard and quality etc. of article shall be final.
17. No advance payment will be made. The payment will be made on successful execution of supply/ works, how ever, subject to satisfaction of this office. Applicable taxes, if any, will be deducted from the final bill of the successful tenderer as per the LT Rules.


18. The Terms & Conditions of this Notice and also further prescribed by this office shall be acceptable to the interested parties. No separate agreement will be executed for the purpose.
