O R D E R

(Under Section 133 of Criminal Procedure Code, 1973)

WHEREAS, it has been noticed that resident of prominent residential locality of all the D.M.C./Village Panchayats areas of Diu District are throwing garbages of shops, offices, schools, industries, house hold and dirty water into the public streets which is unhygienic and injurious to the public health and safety. Such act of the public is also creates air pollution, which is bad for the neat and clean environment absolutely required during this pandemic period ;

AND WHEREAS, the above act of the inhabitancy comes under the definition of "Public Nuisance";

AND WHEREAS, wherever there is a public nuisance, the imposition of section 133 of Cr. P.C. must be felt prevent such activities in the locality;

THEREFORE, in view of the above and in exercise of the powers conferred in Section 133 of Code of Criminal Procedure, 1973, I, **SALONI RAI, IAS, DISTRICT MAGISTRATE, DIU** to stop such Public Nuisance in Diu District hereby order that the following penalties shall be levied and collected from all persons and entities violating the directions issued by the District Administration :-

The above direction including imposition of penalties shall be enforced by Police Department, Diu Municipal Council, District Panchayat, Gram Panchayats with their designated Officers/Officials, Incident Commanders, Executive Magistrate and any other Officers/Officials as order by the undersigned.

This order shall come into force with immediate effect and shall remain in force till further orders.

This supersedes earlier order issued.
