

**TERMS & CONDITIONS:**

1. The auction of Avelling Jessop Road Roller 8/10 Ton Capacity, bearing Registration No GDB-628 and Mahindra and Mahindra Pick up FJ-460DP 4-WD bearing Registration No GDB-9913 shall be carried out under the supervision of the committee consisting of the Executive Engineer, P.W.D., WD-II, Diu, the Assistant Engineer, P.W.D., SD-II, Diu, Divisional Accountant, P.W.D., WD-II, Diu on 20/11/2015 at 04:00 pm.
2. The interested bidder shall have to deposit a token amount of Rs. 1000/- (Rupees One Thousand only) for respective vehicle at the time of auction for taking part in it. The said amount shall be refunded back to the unsuccessful bidder after the auction. The successful bidder has to deposit 10 % of the offered bid on the spot.
3. The bidder should offer bid for a minimum of Rs. 1000/- (Rupees One Thousand only) above the upset price of the vehicle.
4. An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
