

TERMS AND CONDITION: -

1. The auction of Toyota Qualis shall be held under the supervision of the Committee consisting of Deputy Conservator of Forests, Daman & Diu, Diu, Deputy Collector, Diu, Deputy Director of Accounts, Diu and Assistant Engineer, Public Work Development, Sub-Division – I, Diu on 23.07.2015 at 11:00 A.M.
2. The auction shall be held on bid system, interested bidder shall have to deposit a token amount of Rs. 1000/- at the time of auction for taking part in it. The said amount be refunded back to the unsuccessful bidder after the auction. The successful bidder has to deposit 10% of the offered bid on the spot.
3. The bid should be offered a maximum Rs. 500/- above on the upset price.
4. An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
5. The successful bidder shall have to lift the auctioned vehicle within three days from the date of finalization of the auction after which this office shall not be responsible for their safe custody.
6. The interested party should inspect the vehicles themselves about their condition etc, during office hours Monday to Friday up to 18:00 hrs.
7. The bid shall be considered as final only after the approval of the Committee and its decision as regards to any dispute arising in the course of the auction shall be final and binding on all the persons participating in the auction.
8. Right to accept or reject any bid or all the bids without assigning any reason is reserved by the Committee.
