ORDER

- 1. WHEREAS,** this office has received report from Mamlatdar, Diu vide letter no. 6-10-2019-20/CTS/DIU/LND/134 dated: 17/10/2019, that encroachment has been done on the Government land by Shri Bharat Odhavji Solanki, and Smt. Falguni Parshotam Solanki Sea View Hotel, Ghoghla, Diu on an area admeasuring 782 sq.mts. respectively, which is part of land bearing PTS No.22/28, situated at Ghoghla, Diu;
- 2. AND WHEREAS,** Show Cause Notices were issued vide letter No.65-03-Illegal Encr.-2018-LND/1417, dated 06/12/2019 to the above mentioned persons under Section 40 of the Goa, Daman and Diu Land Revenue Code, 1968 as per the report of Mamlatdar, Diu to give explanation for the same and removal of unauthorized encroachment from government land in stipulated time i.e. 7 days;
- 3. AND WHEREAS,** the respondent has submitted letter dated 17/12/2019, stating that her husband Mr. Parshottam Odhavji Solanki is ill and admitted in Hospital at Mumbai, Maharashtra and she is also in Mumbai with him for his treatment, therefore requesting three month time, so that she can get property measured and verified as per Show Cause Notice dated 12/12/2019;
- 4. AND WHEREAS,** the respondents had been given time of 7 days in the Show Cause Notice dated 06/12/2019 for removal of

unauthorized construction and 28days have elapsed since the date of notice;

5. NOW THEREFORE, keeping the above facts and submissions, and it is confirmed from the revenue records that the said parcel of land is government land and therefore the representation from the respondent can't be considered. In view, I, **SALONI RAI , IAS, Collector**, Diu do hereby order under Section 40 of Goa, Daman & Diu land Revenue, Code, 1968, the removal of the encroachment from Government land totally area admeasuring 782 sq.mts. respectively, which is part of land bearing PTS No.22/28, situated at Ghoghla, Diu within one week's time till 10/01/2020 and also order that if encroacher fails to remove the encroachment then the cost of removal of the encroachment from the said Government Land and restoration of the Government Land shall be recovered from the respondent in the form of arrears of land revenue, and direct the Mamlatdar, Diu to do the needful immediately.
