ORDER

In exercise of the powers conferred on me under Section 115 & 116 of Motor Vehicle Act, 1988 and as per the request received from the Chief Officer, Diu Municipal Council, Diu that the work of Underground Sewerage system phase II is under progress. The work of laying of pipeline is already started from Krishna park towards Pumping station, Gandhipara Diu on National Highway and in order to avoid the obstructions to the ongoing Civil Work in Public Interest, it is necessary to restrict the following routes and places as "ONE WAY Roads, Restrict Zone for entry of Vehicle and No Parking Zone" for the period from 06/05/2022 to 17/05/2022 for 12 days.

Sr. No.	Place	Zone
1.	National Highway starting from Krishna Park Circle to Diu Court Circle.	ONE WAY ROAD (No. Parking, No Halting of Vehicle will be allowed on either side, Vehicular Traffic allowed from West to East)

The Chief Officer, Diu Municipal Council, Diu shall ensure to direct the concerned contractor to complete the aforementioned civil work on the above road within prescribed time limit and make the road operational well in time.

Further, in exercise of powers conferred under Section 116 of Motor Vehicle Act, 1988 I hereby authorize the Executive Engineer, P.W.D., Diu for Erection of Traffic Sign Board mentioned above for the purpose of regulating Motor Vehicle Traffic.

In case of violation of above, violating vehicles will be impounded and shall be released on payment of prescribed penalty.

This Order shall come into force from 06/05/2022 to 17/05/2022.
