ORDER

(Under Section 144 of Criminal Procedure Code, 1973)

WHEREAS, it has come to the attention of the undersigned that a novel virus Coronavirus has surfaced in the East Asia which is infecting the human beings in the countries like China, Hongkong, Singapore, Italy and Thailand etc and various states of India also;

AND WHEREAS, the said Coronavirus being contagious needs to be contained from spreading in this District;

AND WHEREAS, for the above mentioned purpose, Health Department is the Nodal Department;

AND THEREFORE, in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, I, Saloni Rai, District Magistrate, Diu hereby order as follows:-

1. All the Resorts and Hotels in this territory shall report to Health Officer, CHC., Diu on toll free Emergency number **104**, regarding any customer(whether India or foreigner), who has traveled from China, Hong Kong, Singapore, Thailand, Italy and any other affected country after 15th January 2020;
2. All the Industries, commercial establishment in this territory shall report regarding any employee, consultant or labourer, who has traveled from China, Hong Kong, Singapore, Thailand, Italy and any other affected country after 15th January 2020;
3. The Police Department in this territory shall report regarding any person, who has traveled from China, Hong Kong, Singapore, Thailand, Italy and any other affected country after 15th January 2020;
4. The Health Officer, CHC., Diu shall prepare a Quarantine Room so as to be prepared to contain the affected persons from the said coronavirus in case needed. It shall regularly monitor the situation in this regard proactively involving every stakeholder;
5. The Health Officer, Diu, shall submit a status report daily positively by 10.00 hours regarding the number of such persons examined, their health status and action taken;

6. The general public is also directed to report regarding any persons who have traveled from China, Hong Kong, Singapore, Thailand, Italy and any other affected country after 15th January 2020 to the above mentioned authorities.
7. To avoid any direct contact with persons affected from Coronavirus, Mass gathering/unnecessary assembly of persons in the District shall be prohibited with immediate effect. Police Department, Diu shall ensure strict compliance. The instruction shall not apply to Schools, Colleges and religious places etc. of Diu District.

This order shall come into force immediately from the date of issue and shall remain in force until 60 days from this date of issue.

As the Order cannot be served individually, the Order is put in the public domain for information and necessary action.
