ORDER

WHEREAS, it is apprehended that terrorist/anti-social elements may seek hideouts in the area of the said Police Stations/Outposts and there is every likelihood of breach of peace and disturbance of public tranquillity and also there is grave danger to human life and safety and injury to public property on that accounts:-

AND WHEREAS, it is imperative to ensure safety that no hotel/paying guest house/lodging house/etc is run without proper permission from competent authorities including licence from Tourism Department, Diu;

AND WHEREAS, it is necessary that some checks should be put on Landlord/Hotel/Guest House/Lodge/Chawl Owners so that terrorist/anti-social element in the guise of tenants/visitors/guests may not cause explosions, riots, shoot outs, affray, etc. and that immediate action is necessary for the prevention of the same;

NOW, THEREFORE, I, SALONI RAI, District Magistrate, Diu in exercise of the powers conferred upon me by Section 144 of Code of Criminal Procedure, 1973 (No. 2 of 1974), do hereby order that no landlord/Hotel/Guest House/Lodge or resort Owners shall let/sublet/rent out any accommodation without proper permissions from competent authorities including licence from Tourism Department, Diu to any person unless and until he has obtained the copy of any reasonable document of identity proof (like Adhaar card, Election I.D. Card, PAN Card, Driving licence, Passport Credit Card or Debit Card and any other reasonable proof of identity with photo) of the said tenants/visitors/guests which falls under the jurisdiction of the area of the Police Stations/Outposts as specified above in this order and unless and until he has furnished the particulars of the said tenants/visitors/guests to the In-charge of the Police Station/Outposts concerned. All persons who intend to take accommodation on rent shall inform in writing in this regard to In-charge Police Station/Outpost concerned in jurisdiction the premises fall;

The person dealing in the property business shall also inform in writing to the In-Charge Police/Station concerned in whose jurisdiction the premises falls about the particulars of the said tenants;

This Order shall come into force with immediate effect and shall be effective for a period of 60 days with effect from 12/02/2020 to 11/04/2020 (both days inclusive) unless withdrawn earlier;

Any person contravening this Order shall be punishable under Section 188 of the Indian Penal Code;

As the Notice cannot be served individually on all concerned, the Order is hereby passed exparte. It shall be published for the information of public through Press and by affixing copies on the notice board of the offices of all U.T. Administration Offices of Diu including the office of the IG(P)DD & DNH. SDPO, Diu, all Police Stations/Outposts/SFO concerned and the offices of the Municipal Council and District Panchayat of Diu.
