ORDER

1. WHEREAS, this office has received a complaint dated 24/02/2021 from Shri Rajendra Daya resident of Bhovan Sheri, Dangarwadi, Diu informing that in the Govt. land bearing Survey No. PTS-49D/204, that, Shri Mohan Ramji Bava resident of Dangarwadi is constructing house in the Govt. land PTS-49D/204 situated at Dangarwadi, Diu.


2. AND WHEREAS, as per above complaint Mamlatdar, Diu has reported to this office that you, Shri Mohan Ramji Bava resident of Dangarwadi have unauthorisedly encroached upon Government land by construction residential building in land bearing Survey No. PTS-49D/204 (Part) areas admeasuring 60 Sq.mts. situated at Dangarwadi Zolawadi District-Diu, vide letter No. MAM/DIU/2020-21/Govt. Land Report/9924 dated 16/03/2021;

3. AND WHEREAS, the respondents have given time limit 07 days time up to 19/04/2021 is the final deadline for necessary arguments to be done in the Court of Dy. Collector, Diu in the office hours in absence of which the decision will be taken ex-parte;

4. AND WHEREAS, adequate time is already given to the respondent to reply to the Show Cause Notice and no reply is submitted by the respondent;

5. AND WHEREAS, the report of Talathi dated 15/03/2021 and subsequent letter sent by Mamlatdar, Diu dated 16/03/2021 clearly states that the PTS No. 49D/204 with area of 60sq.mts. is entered in the name of Government;

6. NOW THEREFORE, keeping the above facts, in view, I, HARMINDER SINGH, DY. COLLECTOR, Diu do hereby order the eviction of the respondent & removal of the encroachment from Government under Section 40 of Goa, Daman & Diu land Revenue, Code, 1968, land bearing Survey No. PTS-49D/204 (Part) areas admeasuring 60 Sq.mts. situated at Dangarwadi Zolawadi District-Diu immediatly and also order that if encroacher fails to remove the encroachment

then the cost of removal of the encroachment from the said Government Land and restoration of the Government Land shall be recovered from the respondent in the form of arrears of land revenue, and direct the Mamlatdar, Diu to do the needful immediately.
