**O R D E R**

( Under Section 133 of Criminal Procedure Code, 1973 )

**WHEREAS**, it has come to the notice of the undersigned that an outbreak of Avian Influenza or Bird flu cases has been reported;

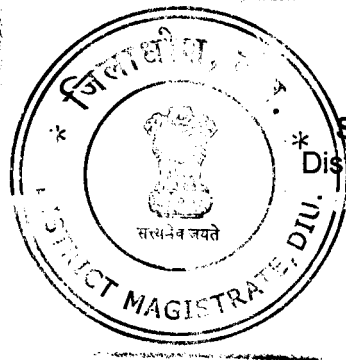
**AND WHEREAS**, it is expedient to make necessary arrangements to stop it from entering in Diu District and take precautionary measures to contain the spread of Avian Influenza (A.I.) or Bird flu cases to prevent it from becoming a public nuisance;

**AND WHEREAS**, the undersigned is satisfied that the conduct of trade of poultry birds and keeping them unmonitored may be injurious to the health of the people in the District of Diu thereby making it a Public Nuisance;

**AND WHEREAS**, it is imperative to take necessary action in order to contain the spread of A.I. or Bird flu and remove this public nuisance in the interest of general public;

**THEREFORE**, in view of above and in exercise of the powers conferred under Section 133 of the Code of Criminal Procedure, I, **Saloni Rai, District Magistrate**, Diu, hereby order as follows :

1. The entry of all poultry and non-poultry birds from all the States shall be banned;
2. All the shops selling frozen poultry items shall be closed down with immediate effect till further order;
3. All Hotels are advised to refrain from consumption or sale/purchase of chicken related dishes;
4. The Superintendent of Police, Diu shall ensure that necessary security arrangements are made at Entry and Exit Points of the District of Diu;
5. The Motor Vehicle Inspector, Diu shall ensure that the official posted at all the Check Posts shall ensure a thorough check of all the Commercial Vehicles to restrict the entry of above mentioned birds; and
6. The Chief Executive Officer (District Panchayat), Chief Officer, Diu Municipal Council and Veterinary Officer, AHVS, Diu, shall carry out a Surveillance in their respective jurisdiction and submit a daily report to this Office.
