

DIU ON 25-11-2016 AT 05:00 P.M. TO DECIDE THE NOMINATIONS OF 03  
MEMBERS FOR THE DISTRICT LEVEL COASTAL REGULATION ZONE  
COMMITTEE FOR DIU DISTRICT.**

  4. Vide this office letter No. 65-1-2016/LND/CRZ/2054 dated 31-08-2016, Police Verification Report in respect of above 09 names were sought from the Superintendent of Police, Diu and subsequently, the report was obtained vide letter No. 160/AP/DIU/PVT/ 2016/382642 dated 31-08-2016.
  5. Meantime, this office received two statements from the Sarpanch, Village Panchayat, Saudwadi & Bucharwada-Diu respectively which was beyond 07 days time limit. Hence, the names suggested were not considered.
  6. The details of 09 names suggested above were consolidated with other details like address, educational qualifications, fishing experience and Police Verification Report etc.



7. Accordingly, a meeting was organized in the Chamber of Collector and District Magistrate, Diu on 08/07/2016 at 04:00 p.m. and the above 09 names were scrutinized.
