**ORDER**

**(Under Section 144 of Criminal Procedure Code, 1973)**

**WHEREAS**, in the wake of outbreak of coronavirus (COVID-19), World Health Organisation declared it as a pandemic, and the Total Lockdown has been announced w.e.f. from 25<sup>th</sup> March, 2020 in order to contain the spread of the said virus;

**AND WHEREAS**, the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu is taking necessary steps to effectively enforce the above mentioned directions by the Hon'ble Prime Minister of India, wherein the main focus is to minimize unnecessary movement of general public;

**AND WHEREAS**, it has come to the attention of the undersigned that some of the citizens of Diu District who are residing outside are entering Diu either through sea route by swimming, boats or through beaches without knowledge of Incident Commanders and authorities deployed at both Check posts, which is a great concern due to Coronavirus which has spread all over the world and various States of India;

**AND WHEREAS**, so far no Coronavirus cases have been detected in Diu District;

**AND WHEREAS**, to avoid any spread of same inside Diu District, the persons coming from abroad, various States of India and nearby State of Gujarat need to be quarantined by proper screening by the Health Department as per the guidelines issued by the Ministry of Health and Family Welfare, New Delhi and the SOP being followed by Diu Administration;

**THEREFORE**, in view of above and powers conferred under section 144 of Code of Criminal Procedure, 1973, **I, SALONI RAI, IAS, District Magistrate, Diu** hereby order as follows;

1. A strict vigil needs to be adhered at the sea side, creek side and check posts and proper security needs to be deployed avoiding persons entering from the said area in Diu District.
2. Strict facility & home quarantine shall be observed by all persons who are entering in Diu District to avoid risk of spreading Covid-19 in Diu District.
3. If any person is found entering Diu District by sea side, creek side or check posts without screening and not quarantined in home/facility quarantine without following guidelines of the Ministry of Health and Family Welfare, New Delhi shall be punished under Section 188 of Indian Penal Code.
4. No person should move across borders of Diu to/from adjoining district/ any other state without seeking valid permission for the same and informing to the authorities.

This Order shall come into force immediately from the date of issue and shall remain in force until further orders.

As the Order cannot be served individually the Order is put in the public domain for information and necessary action.
