CURFEW ORDER

(Under Section 144 of Criminal Procedure Code, 1973)

WHEREAS, this office had issued Order No. 32-21-2009/MAG/2019-20/36 dated 05/04/2021 in connection with the Curfew Imposed between 08.00 P.M. to 06.00 A.M.

AND WHEREAS, in continuation of the above Order, it is observed that the number of active cases of COVID-19 have been raising continuously in last few weeks in the neighboring States of Maharashtra and Gujarat;

AND WHEREAS, various guidelines alongwith Standards Operation Procedure (SOP) has been issued by Diu District administration from time to time for the containment of the spread of COVID-19 in the District;

AND WHEREAS, it is imperative that strict and intensified measures need to be undertaken with immediate effect in order to prevent and further contain the spread of the COVID-19 virus in the District of Diu;

AND WHEREAS, it is pertinent that social distancing and isolation measures for the containment of the spread of COVID-19 should be strictly adopted;

AND WHEREAS, the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu has issued Order and Addendums as preamble above;

NOW THEREFORE, in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, I, **SALONI RAI, IAS, District Magistrate, Diu** in the interest of Public Health Safety hereby order that **the complete Curfew is hereby imposed on all weekends i.e. Saturdays and Sundays, with effect from 17/04/2021 till further orders. However the operation of essential and medical services, delivery of food items, Industrial workers commuting for shift duties are exempted from this.**

This order shall however, not apply to: -

- (1) Police personnel (2) Military and Para Military Personnel in Uniform (3) Doctors, officers on emergency services & Govt. functionaries on duty on production of Identity Cards (4) Members of Home Guards on duty and (5) The persons to whom a Authority/Permit/Identity Card is issued by the District Magistrate, Diu to any other Officer/Officials in this behalf.

This order shall come into force with immediate effect from the date of issue and shall remain in force till further order.

As the notice cannot be served individually on all concerned, the order is hereby passed ex-parte. Any persons violating these measures will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC and other legal provisions as applicable.
