

READ: Order No. 32-21-2009/MAG/2019-20/838 dated 31/05/2020

ORDER

(Under Section 144 of Criminal Procedure Code, 1973)

WHEREAS, Corona Virus (COVID-19) has been declared as pandemic by World Health Organization, urgent public Health measures are required to be taken to control the transmission of the Corona Virus;

AND WHEREAS, UT Administration has extended the lockdown in containment zone, if so declare upto 30-06-2020 and has permitted re-opening of the prohibited activities in a phased manner in the entire territorial jurisdiction of the U.T and issued guidelines for the same as referred above;

AND THEREFORE, in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, **I, SALONI RAI, IAS, District Magistrate, Diu** in the interest of Public Health Safety hereby order as under;

- 1. Vegetable Markets in Urban area and Rural area shall remain open all days between 7.00 a.m. to 7.00 p.m.**
- 2. Health Officer, CHC, Ghoghla, Diu will take sample for test of COVID-19 of all vendors coming from outside Diu in Vegetable Markets.**
- 3. General Public shall maintain social distance in Vegetable & Fish Markets.**

This order shall come into force with immediate effect and shall remain in force till further orders.

As the notice cannot be served individually on all concerned, the order is hereby passed ex-parte. Any person contravening this order shall be punishable under section 188 of the Indian Penal Code.

This supersedes earlier order quoted above.
