**ORDER**

The Hon'ble Supreme Court of India vide judgment / order dated 15/12/2016 in civil appeal No. 12164-12166 of 2016 directed as under:

- i) All states and union territories shall forthwith cease and desist from granting licenses for the sale of liquor along national and state highways;
- ii) The prohibition contained in (i) above shall extend to and include stretches of such highways which fall within the limits of a municipal corporation, city town or local authority;
- iii) The existing licenses which have already been renewed prior to the date of this order shall continue until the term of the license expires but no later than 1 April: 2017.
- iv) All signage's and advertisements of the availability of liquor shall be prohibited and existing ones removed forthwith both on national and state highways;
- v) No shop for the sale of liquor shall (i) visible from a national or state highway; (ii) directly accessible from a national or state highway and (iii) situated within a distance of 500 meters of the outer edge of the national or state highway or of a service lane along the highway.

**AND WHEREAS,** Highway No.251 starting from its junction with NH-51 near Una in the State of Gujarat connecting Ghoghla in the Union Territory of Daman and Diu and terminating at NH-51 near Kesaria in the State of Gujarat has been declared as National Highway vide Gazette notification dated 04/03/2014 by Ministry of Road, Transport and Highways.





**AND WHEREAS,** the committee has identified 100 (One hundred) such licenses for sale of liquor situated within the distance of 500 meters of the outer edge of the new national highway No. 251 which starts from junction with NH-51 near Una in the State of Gujarat connecting Ghoghla to Diu and from Kesaria upto Tad which are listed in the Annexure-I attached herewith.

**AND WHEREAS,** in compliance with the said order / judgment, the Excise Department issued notice dated 21/01/2017 to all 100 (one hundred) the license holders of Daman & Diu which are situated within distance of 500 meters of NH 251 in Diu District for strict compliance of the order / judgment of the Hon'ble Supreme Court of India.

**NOW THEREFORE,** all the license holder listed in the annexure-I are hereby informed that in light of the order dated 15/12/2016 of Hon'ble Supreme Court of India, all these licenses shall stand cancelled w.e.f. 01/04/2017.
