**Draft REPORT OF REHABILITATION &**  
**RESETTLEMENT SCHEME**

It was notified by Collector, Diu, UT Administration of Daman & Diu vide Preliminary Notification No. 65-03-LAQ-/2018-19/928 dated 10/09/2019 that the lands described in the schedule hereto (thereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for the purpose of **Construction of Missing link road from Diu Fort Parking behind Govt. Circuit House upto Church road at Firangiwada, Diu.**

The report dated 13/11/2019 received from the Mamlatdar, Diu mentions that livelihood of land holders of the said area is not directly dependent on the land being acquired. The present condition as observed by the Rehabilitation and Resettlement Committee dated 13/11/2019 found that the land is neither used for residential purpose nor for business activity by the family members of land owner. At present there is only three parcels of land are affected in land acquisition totally admeasuring 894.00 sq.mts. land which are under acquisition for Construction of Missing link road from Diu Fort Parking behind Govt. Circuit House upto Church road at Firangiwada, Diu.


